Preface to the Second Edition

As I write these lines, Russia's invasion of Ukraine is progressing at a slow and brutal rate, leaving tens of thousands dead and wounded in its wake on both sides, and turning increasingly large swaths of Ukraine into utter dust and rubble. Because the West is massively supporting Ukraine's defensive efforts, Russia is making increasingly shrill threats of escalating this war into World War III, including nuclear attacks on various European capitals. Of course, a nuclear exchange between Russia and the West could leave the entire planet devastated, plunging Earth into a nuclear winter that may wipe out life on Earth as we know it.

The situation is bizarre. The Russian government justifies its war by claiming that Ukraine is run – or at least dominated – by Nazis, and that "de-Nazification" justifies war, mass destruction and mass annihilation. This rhetoric comes straight from the propaganda playbooks of the Second World War. But official Russia goes even a step further. When 40 leaders of Western nations met in Brussels in late April 2022 in an effort to coordinate their assistance to Ukraine, Russian state-controlled media were quick to equate these 40 leaders with 40 Hitlers, all Nazis, unified in their support for Nazi Ukraine, and that Russia may have to extend its campaign to now de-Nazify and demilitarize all of NATO.

There is no doubt that nationalism holds stronger sway in Ukraine than in most Western nations, and Russia's attack has intensified those feelings among Ukrainians holding such views. It is also true that Ukraine and the West are now getting militarized as they haven't been in decades, but this is merely a reaction to Russia's war of aggression.

Bringing Western nations into any context with Nazism is absurd, considering that any manifestation of "Nazism" is suppressed by all means possible, including the penal law in many of those countries.

So how did we get to the point where mankind may cause the extinction of all higher life forms on our planet? How is it that the language, attitudes and actions of official Russia have become so grotesquely detached from reality?

It is safe to say that Russia's government would not be able to do what it is doing if Russians had full access to all information, the unfettered right to speak their minds publicly, and to assemble in public to voice their views. Censorship and disinformation are what allows the Russian government to get away with this grotesque behavior, which otherwise would undoubtedly lead to yet another revolution in Russia to overthrow the current despotic regime of mass annihilation, one in a row of regimes Russians had to put up with over the past more than a hundred years.

This highlights the impact and importance of freedom of speech. With it, mankind may prosper, but without it, we are teetering on the brink of not just our own species's extinction.

ten even for those not directly involved. To believe that Western media tell the unvarnished truth would be naïve. After all, when it comes to principles, the West isn't all that different from Russia, which makes Russia's anti-Western anti-Nazi propaganda even more bizarre.

Strictly speaking, both Russia and the West are actually doing the same thing. They declare certain perceived enemies as "Nazis", use censorship laws to prevent those thusly labelled from publicly voicing their dissent, lock up obdurate dissidents in prisons for years, and make sure that any "Nazi" will find it impossible to make a living.

Ever since the end of the Second World War, the term "Nazi" has been used by every regime on the face of the earth to de-humanize individuals that they have targeted for annihilation, if not physical destruction, then at least economical and social ruin. Once a person or group has been identified as "Nazi", that person or group is fair game. Even lynch justice by a mob riled up by media propaganda is perfectly acceptable in the "civilized" West, as long as the victim is a "Nazi."

The term "Nazi" arouses feelings in most people that equate with the feelings once harbored by many during the Dark Ages when the term "devil" or "witch" was uttered. Anything is allowed in fighting demons, devils, witches and "Nazis." In fact, this basic instinct of visceral hatred against someone perceived as the personification of absolute evil is much older than this and probably goes back to our species's early, barbaric origins millions of years ago. The medieval witch-hunts were only one of its many manifestations. But while the medieval witch-hunts were limited to certain areas of Christian Europe, today's anti-Nazi witch-hunts are almost global in nature. Say the word, and the Pavlovian dogs will bark, hunt, and maul the "Nazis" all over Planet Earth.

It works every time, everywhere. Not just in Russia and Russian-occupied Ukraine.

I have news for the world: Nazis, actual and alleged, are human beings like everyone else, with the same civil rights as everyone else. And chances are that many if not most of those who are stigmatized as "Nazis" in fact embody the masses' prejudices about "Nazis" as little as the medieval witches managed in fact to embody their contemporaries' delusions about them.

It's a matter of mass hysteria more than anything else.

The present book tells a story of how the Western world and Russia – they act in total unison in this regard – destroy freedom of speech for the sake of destroying what they falsely perceive – or mendaciously claim – to be "Nazis." Their victims are as little Nazis as Russia's victims in Russia and Ukraine are Nazis. This is not to say that there aren't people in Ukraine or among historical revisionists who have sympathies for certain aspects of National Socialism. But as the current war in Ukraine shows, while real Nazis in today's world of witch-hunting them are no danger to anyone, suppressing free speech can and does lead to wars, which may destroy life on earth as we know it.

The present chronicle of the destruction of free speech in the West runs parallel to the ongoing genocidal war of extermination which Israel has been waging in the Middle East since Israel's inception, which is also a conflict that could very well go nuclear. Clearing the Clouds of War A Foreword

The millions who died in and of World War II are gone from us forever, as are their descendants in time who otherwise would have been born and alive today, 75 years later. The vast physical destruction has been repaired, replaced, buried, paved over and even, like the Memorial Church in Berlin, preserved in a ruined state. The erstwhile belligerents now are trading partners, even allies, though the victors continue to maintain military bases on the territories of the defeated countries.

But a certain pall continues to becloud understanding of that awful past that with the passage of time seems to abate not at all but rather to intensify, producing in this very late day more and ever more laws criminalizing the expression of beliefs; and more newly minted "criminals" who fall afoul of the new crimes, and new monuments to manufactured hatred such as the great one recently built in London, and attacks such as the arson attack on July 4, 1984 against the office building of the Institute for Historical Review in Torrance, California.

There is in today's world one entire sovereign nation devoted to the defense and exacerbation of this cancerous legacy of the most-devastating war in human history, and at last count nineteen other countries having enacted criminal laws against opposing this suppurating campaign, plus numerous others otherwise officially in league with it, including the world's only superpower. The US government annually appropriates millions of dollars to the budget of the monument to hatred erected on the Mall in Washington, DC, while state after state inserts into its statutes laws mandating the indoctrination of all the hapless schoolchildren in all schools in the state, both public and private. In this – and only this – form does World War II rage on, and on and on, poisoning afresh the hearts and minds of each new generation as it is frog-marched through the portals of "learning."

There is, however, a dogged peace movement whose thus-far-losing campaign to efface this malady of humankind's soul has never ceased and, despite the odiferous labels attached to it by its malefactors, calls itself "revisionism." Its soldiers daily face opprobrium, social ostracism, threats to their livelihood, and against members of their families; and yes, to life itself, attacks they suffer in pursuing this last, precious blessing of peace, while subsisting on such meager incomes as their amply-moneyed opponents have failed to prevent their eking out.

The author of this work is a stalwart of the first rank in this movement. Of the many years, Germar Rudolf has given over to the uphill battle for truth about what the opposition calls "the Holocaust," he spent almost four in German prisons, convicted of the crime of having expressed his illegal opinions in public, aggravated by his scientific arguments that have proven impossible to refute (he is a degreed chemist). to the war-torn phantasmagoria dominating the record concerning the Holocaust.

Until March 6, 2017, a day that will live in intellectual infamy, Amazon carried all the titles of Castle Hill Publishers, the publishing arm of the Committee for Open Debate on the Holocaust (CODOH), in keeping with the 1998 declaration of Amazon's CEO, Jeff Bezos, to offer "the good, the bad, and the ugly." But on that black day, Bezos's bold declaration went down the drain, as every title in every language in every medium, new and used alike, was expunged from Amazon's vaunted list, consigned to a state George Orwell might have called "unbooks" in parallel with the concept he introduced of the "unperson." Down the Memory Hole.

The health of the Holocaust legend is, it might be said, the health of Jewry, but that term encompasses not only millions who have no hand in the maintenance of the myth, and moreover do not even benefit from it. The chief institutional beneficiary in this world is the state of

Israel. Considering the interests and worldwide repute of Israel and its powerful amen chorus both within and without Jewry, it is telling that the campaign of censorship here reported initially spared many works hostile to either Jews/Judaism or Israel. Still "standing" [as of early 2018] were not only Henry Ford's scurrilous *The International Jew* series of the 1920s, but also the myth-busting works of Shlomo Sand (*The Invention of the Jewish People*) and Norman Finkelstein (*The Holocaust Industry*). [All editions of Ford's books have since been banned by Amazon. G.R.]

What does this selectivity disclose? Does it, perhaps, speak to the centrality of the Holocaust mythology in justifying the policies of the state of Israel since its bloody conquest of Palestine in 1948? To some extent, yes, but I submit there is a further, amplifying factor in the intensive targeting that revisionism has been subjected to, leading to this latest disruptive success, and that is the persuasiveness, the sheer logical and scientific force of the revisionist movement's oeuvres of the past ten to fifteen years. The weight of it, I say, has become unbearable to Zionism's advocates. And so, camouflaged by attacks – initially merely rhetorical – on anti-Semitic material, the onslaught has been directed surgically, so to speak, against the very tip of the spear, Holocaust revisionism, under the false motive of combating

hatred.

It is, of course, the Holocaust mythology itself that most promotes the spirit of hatred against Germans, Nazis and their various allies in the course of the Second World War, all of whom (including their descendants) are tarred with the accusation of genocidal intent towards Jews. In keeping again with the incomparable Orwell, this campaign reprises slogans appearing in his book 1984, such as "ignorance is strength" and "war is peace" – a diametrical inversion of the truth. But through repetition and endorsement by respected figures in the temples of truth, the tar has been made to adhere to revisionists.

The defenders of Holocaustery often cite the "obscure" status of works expressing doubts of the regnant mythology, an obscurity reinforced by Amazon's delisting such works.

Setting the Stage

When the Communist Eastern Bloc collapsed starting in the late 1980s, freedom of speech and freedom of information were savored by many Eastern European nations for the first time in many decades. Freedom of information also meant the possibility to gain access to many archival materials which so far had been accessible only to a selected few, or whose existence had been kept a complete secret during the Cold War. Among those archival materials were also many German wartime documents which had been captured by the Soviets at the end of World War Two.

For instance, take the records of the Central Construction Office of the infamous Auschwitz Camp. This office was the authority in charge of all construction projects in the camp, including the crematoria which are said to have contained homicidal gas chambers. For decades, mainstream historians thought that these records had been destroyed by the Germans prior to their retreat. That was not the case, however. After the Red Army had captured the camp in January 1945, the records of this office were secretly transferred to Moscow, where they were kept under lock and key until the early 1990s. Only then did the public find out that this vast resource of tens of thousands of documents exists. They are now stored in the Russian War Archives (transliterated from Cyrillic: *Rossiiskii Gosudarstvennii Vojennii Archiv*).

Other documents from the Auschwitz Camp, for instance a large collection of records kept by the Auschwitz camp headquarters, ended up in the Russian Federal Archives in Moscow (transliterated: *Gosudarstvenni Archiv Rossiskoi Federatsii*).

Another set of documents not readily accessible for Western scholars were the War Archives of the Waffen SS, which the Waffen SS had kept in German-occupied Prague during the war, out of the reach of Allied bombers. There they were taken over by the communist Czech government after the war, which kept them mostly hidden from curi-

ous Western eyes suspected of not toeing the party line. Since the Auschwitz-Birkenau Camp was initially designed as a PoW camp of the Waffen SS, quite a few documents about that camp ended up in Prague. They are now located in the Military History Archive in that city (Vojenský Historický Archiv).

Two more archives worthy of mention in this context are the archives of the Auschwitz State Museum, whose holdings were made accessible only reluctantly to Western scholars during the cold war, and the archives of the Central Commission for the Investigation of Crimes against the Polish People – National Memorial, located in Warsaw (Archiwum Głównej Komisji Badania Zbrodni Przeciwko Narodowi Polskiemu Instytutu Pamieci Narodowej). The latter contains many documents pertaining to legal proceedings initiated after the war by the Polish authorities against individuals accused of having been involved in running labor, concentration and so-called extermination camps.

It goes without saying that many of these documents are highly interesting to World War Two historians. former German camps in Poland,

such as Majdanek¹ and Auschwitz, which were overrun by the Red Army in late 1944 and early 1945. The documents captured in those camps often disappeared from public view. In the wake of the collapse of the Soviet Union, however, Russia, Czechoslovakia and Poland, the three nations where most of these archival materials ended up, allowed not only government-accredited researchers but also independent scholars access to their archival holdings in the early and mid-1990s.

A small group of independent scholars² started to systematically evaluate some of these long-lost documents and to write exhaustive treatises on what they found.³ These rediscovered documents allowed for the first time the writing of an accurate history of these camps without the distortion of the propaganda of World War Two and the Cold War.

There was another set of researchers writing under various pen names and led by the late German architect Willy Wallwey, of whom no portraits are known to exist in the public domain.

The result was that the historical narrative of basically every single one of those German wartime camps required drastic revision.

To give just one example, let's take the Majdanek Camp near the

Polish city of Lublin. Shortly after the capture of the camp, the Soviets claimed a death toll of some two million for that camp:⁴

danek death toll was set at 1.7 million.5


During the Nuremberg International Military Tribunal, the Soviets introduced an investigation report claiming that up to 1.5 million inmates had been killed in that camp using seven different gas chambers, among other methods.⁶

This figure, however, was significantly reduced three years after the war, when Polish judge Zdzisław Łukaszkiewicz, a member of the Polish "Commission to Investigate German Crimes in Poland," published this commission's findings about Majdanek, which set that camp's death toll at 360,000, a number which was displayed at the Majdanek Museum for several decades.

Various death-toll claims made about the Majdanek Camp since its capture by the Soviets in August 1944. See text for details.




Scene from the Polish show trial against six former German camp guards of the Majdanek Camp, where the camp's death toll was set at 1.7 million.

The next downgrading came after the collapse of the communist Eastern Block, when Polish historian Czesław Rajca reduced the death toll to 235,000.8

A short while later, independent researchers got access both to the Majdanek camp archives and to the remaining physical structures. Based on a thorough evaluation of the material evidence and the vast documentation, they demonstrated in their 1998 book, which is currently available in its third English edition, that there had never been any execution gas chambers in that camp at all, and that the death toll according to the camp's records amounts to some 42,000, mainly due to diseases and malnutrition resulting from the irresponsible way the camp was run by the SS.⁹ This is still a shockingly high number, but it is a far cry from any of the numbers claimed by mainstream histo-

riographers so far.

In a detailed research paper of 2005, Tomasz Kranz, head of the Majdanek Museum, decided to streamline the official narrative by reducing the death toll to 78,000, and to ditch five of the seven initially claimed gas chambers.¹⁰

We can see from this that the official Polish narrative of that camp is today much closer to the revisionist position than it is to its own initial narrative at war's end. I admit that this is an extreme case of official revisionism, but it shows that claims are not necessarily true because a mainstream scholar or institution says so, just as a claim is not necessarily wrong because it is made by dissident scholars. In the end, the proof lies in the pudding, namely the evidence adduced.

Since the late 1990s, revisionist scholars have published many iconoclastic works similar to that on Majdanek about other camps as well.


The main focus has always been on Auschwitz, simply because the documentation available for that camp is so massive, and also because the facilities at that camp are to a large degree still extant, and hence, accessible to examination. In particular the Italian scholar Carlo Mattogno has written detailed studies on the various aspects of extermination claims made about Auschwitz (see the cover artwork on the next page).

- He published a study on the very first gassing of inmates claimed to have happened sometime during 1941;¹¹
- a study on gassings in Crematorium I, which supposedly followed that first gassing in late 1941 or early 1942;¹²
- a study on the so-called bunkers of Auschwitz, where the gassing activities were allegedly moved to in early 1942;¹³
- another study which focuses on claims of gigantic open-air incinerations that are said to have happened in 1942 and 1944 near



these bunkers and also near one of the Birkenau crematoria; 14

- a study with a focus on the gas chambers claimed to have existed inside the four Birkenau crematoria;¹⁵
- two studies focusing on charges that inmates subjected to "special treatment" ended up being killed, mainly in gas chambers;¹⁶
- a study investigating in detail the department of the Auschwitz camp authorities that, among other things, was in charge of building and maintaining the crematoria, including the gas chambers they ostensibly contained;¹⁷



study in three volumes on the cremation furnaces of Auschwitz which presumably served to destroy all traces of the mass-murdered victims.¹⁸

There are a few more studies on specialized topics plus several scrutinizing witness testimonies, but I won't include them here. The books listed have together more than 3,500 pages. Consider, then, the best performance orthodox historians have been able to muster so far. It is the five-volume study *Auschwitz 1940-1945* edited by two historians of the Auschwitz Museum who were trained during the communist-propaganda era. However, only Volume 3 titled "Mass Murder," the thinnest of them all with not even 270 pages of text, deals with extermination claims. It is dismally superficial, and covers each claimed extermination location with only a few pages each. It's a pathetic display of incompetence – or lack of an argument.

Hence, with their massive, extremely thorough studies, revisionist historians have won the evidentiary battle raging about Auschwitz hands down. The official Auschwitz narrative lies shattered in a million pieces, and it is irredeemably relegated to the dustbin of history.







State Censorship and How to Avoid It

Needless to say, mainstream historians don't like their lives' work exposed as shoddy scholarship based on the shaky foundations of wartime propaganda claims. But their self-image doesn't matter. 

utter needs to be banned, indeed! And that the revisionists be treated accordingly! Never mind that revisionist research books are not about politics, ideologies, religion or ethnic groups, but only about verifiable historical and scientific facts. But who would know that, unless you read them? Alas, they are banned in many countries and, hence, cannot be obtain in any legal way!

For this reason, freedom of speech and information is but a distant memory in most European countries.

While governments might feel inclined to ban books whose contents they don't like, Amazon operates on different terms. Or at least it used to.

In 1998, Jeff Bezos, the founder of Amazon, gave a speech at Lake Forest College in Lake Forest, Illinois, where he explained the background of his company's success story. Watch it at the link given, if you are interested in the whole story.²¹ In the context of this presentation, let's hear what Bezos said back then about what kinds of books he means to offer to his customers, that is, to us all:

"It's one of the things that surprises people, sometimes upsets publishers and authors, is that we let people enter negative reviews. And they say: 'Why do you do this? You only make money if you sell the books. Why don't you weed out the negative reviews?' And the reason is because we're taking a different approach. We're trying to sell all books. We want to make every book available. The Good, the Bad and the Ugly. And when you're doing that, you actually have an obligation, if you're going to make the shopping environment one that's actually conducive to shopping, to sort of

let truth loose." (Starting at 19:15:00)

Of course, there is a limit to what Amazon will offer for sale, and for many years that boundary was defined by the laws of each country where Amazon sold its items, and that's fine. We may argue about the censorship laws of certain countries, but that isn't Amazon's fault. They have to abide by these laws, as we all have to, or else face consequences, like being prosecuted or being sued by certain lobby groups for selling revisionist books in Germany.²² As this example shows, there has always been a lobby that has been trying for years to bully Amazon into banning items that are perfectly legal, at least in marketplaces such as the United States, where the First Amendment to its Constitution prevents the government from passing laws limiting free speech. Books with views on Germany's wartime camps that diverge in unpopular ways from the standard narrative are at the top of the list of that lobby:²³




For years, Rabbi Mendy Cohen of Sacramento, Cal., has been on a mission to have Amazon ban historical research results he detests, smearing it as "blatant anti-Semitism."²³

Until early 2017, Jeff Bezos didn't budge. He stood by his ideal to offer the Good, the Bad and the Ugly. Of course, what is ugly lies entirely in the eyes of the beholder, and what is good or bad depends on one's moral or quality standards. Letting the reader decide this by posting their reviews was exactly the way Bezos thought the wheat should be separated from the chaff:







the Holocaust, as it was posted on Amazon until 2018 – see the illustration on the next page – we found there that it had seven reviews. All of them gave the book the best possible evaluation: five stars. It's rare to see unequivocal praise for any book, let alone for one that the mainstream hates with a passion.

Of course, that which must not be true, cannot be true. Thus, a while after the publication of the first English edition of the present book in early 2018, this review page of the *Lectures*



was silently deleted, as I had predicted in this first edition, where I wrote:

"Now that I write this publicly, [that this review page is still up] they'll probably send out their army of trolls in order to write a zillion bad reviews and to pressure Amazon into taking down that item completely..."

They didn't write any bad reviews, but they sure took down that review page. Why that page was still there at all after the book itself had been removed in March 2017 is beyond my understanding, but I'm not complaining about it....





Raising the Stakes

In early July 2016, revisionist Holocaust scholar Carlo Mattogno published a study rebutting an ebook by two New Zealand authors claiming to refute revisionist accounts of the Holocaust (James and Lance Morcan, *Debunking Holocaust Denial Theories*). The print editions of both books were actually made publicly available on the same day on Amazon. They had similar titles, and they had similar cover designs, as you can see below. Since the Amazon sales page of Mattogno's book has been obliterated, this juxtaposition will have to do. I will get to the reason for this obliteration later. Anyway, an Amazon customer looking for one of these books automatically found the other: book and counterbook, thesis and antithesis. It was then up to the customers to make up their minds: which book to buy, or maybe even to buy both and make their own synthesis: Who is right, and who is wrong? Who has the better arguments? It is the ideal of the free market of ideas. Amazon offered it. And the interesting thing was that customers




Meant to boost the sales of the anti-revisionist book, this press release by the New Zealand publishers backfired on them by only boosting our rebuttal...²⁵

initially bought both books with roughly the same frequency: The one confirming the orthodox Holocaust narrative, and the other revising it. That game changed when the New Zealand media picked up on that feud.²⁵ Sales went up, but not so much for the anti-revisionist book, whose sales stayed pretty much flat. Mattogno's counterattack was what the media were unwittingly supporting, although they were vilifying it. There is no such thing as bad press for those who otherwise receive the silent treatment.

Encouraged by this, we issued a series of books that we strategically



Left: book for sale on Amazon.com; right: revisionist counter book, once also for sale on Amazon.com.



placed in the Amazon marketplace by giving them titles and cover designs which reprised the books we were targeting, criticizing and refuting. On this and the next page are shown three more of them, with their opposing books on the left as advertised on Amazon in February 2018. Back then, when I took these screenshots, the paperback issue for one, van Pelt's *The Case for Auschwitz*, had only one review, by the way, and it was unfavorable, because the reviewer was outraged by Mattogno's rebuttal being banned by Amazon. The reviews for the hardcover edition of van Pelt's book are roughly split between two extremes: one half consists of uncritical praise, the other of readers

pointing out that van Pelt's book has been thoroughly debunked by the revisionist tome shown here.

The results of our efforts were clear: as long as they were available on Amazon, our books sold in similar quantities as those of our intellectual opponents. Our books certainly also had bad reviews on occasion, but they usually consisted of disconnected, hysterical vituperations. But that did not hurt our sales, because as Jeff Bezos put it succinctly:

"And I'm also convinced that there's a little piece in the human brain that can immediately tell by reading somebody else's writ-



ing whether the person is smart or crazy within like the first five words."

In other words, thanks to the level playing field Amazon offered, Holocaust revisionism was slowly but surely gaining the upper hand.²⁶ It goes without saying that this must have triggered quite some alarm bells among the enemies of free speech. They must have been quite scared and anxious in view of the equal fighting chances granted by Amazon. But what could they do about this inexorable advance of Holocaust revisionism?

What they did about it is described in the next chapter.

Fake Anti-Semitism

A wave of bomb threats against Jewish community centers swept through the U.S. in early 2017, as CNN reported:²⁷

"The FBI and the Justice Department are investigating a new series of bomb threats directed against Jewish community centers across the country. The JCCs reported 11 bomb threats on Monday alone. That brings the total number to 69 threats in 27 states just over the past six weeks, most of them falling on just four dates. Fortunately, though, no bombs have been found so far."



That wave of anti-Jewish activities culminated on February 20 in acts of vandalism against a Jewish cemetery in St. Louis, or so the media reported, here in the words of CNN:²⁸

"Also on Monday, look at this! More than a hundred headstones were found vandalized at a Jewish cemetery in Missouri. It's not clear yet if there is any link to the bomb threats, though."

Shortly after that, the world's media started spreading the news that Israel's government-sponsored Yad Vashem Holocaust Memorial Center, referring specifically to these "antisemitic attacks" in the United States, started putting Amazon under pressure to remove any and all material that questions the orthodox Holocaust narrative,²⁹ claiming that it spreads anti-Jewish hatred and thus fuels these recent attacks (see the illustration on the next page). Never mind that Jews as such, let alone their religion, aren't even a topic in the targeted books.

Riding the wave of outrage about these anti-Jewish attacks, Yad Vashem's efforts were spread far and wide through the mass media, as a Google search with the terms "Yad Vashem Amazon denial books" shows. I show on the next pages a few media items, but rest assured, this is only a tiny fraction of the news coverage this Yad-Vashem initiative received.³⁰ You get the picture. The heat was turned up on

AThree Jewish cemeteries were "vandalized" within a few days, or so we were told...³¹

At first, nothing happened. But then, six days later, as if ordered to emphasize the urgency of Yad Vashem's request, another Jewish cemetery was vandalized, this time in Philadelphia.³¹ Then, on Mar. 3, 2017, another Jewish cemetery, this time in New York, allegedly fell victim to vandalism, but that case was retracted a short while later.³²

"Eyewitness News. Hi there, I'm Natasha Barrett in our newsroom with an update with the story we've been following from New York. The NYPD has now said this: that they have determined that these gravestones damaged at a Jewish cemetery over in Brooklyn, they now say they weren't vandalized. Police say they investigated the reports of possible vandalism that went on, they thought, at Washington Cemetery, a Jewish burial ground, but investigators now say the damage was likely caused by some maintenance, maybe possibly some wind, environmental factors, they say, and the cemetery operators even concur with the findings of the detectives."

...but then came the retraction: those tombstones, and maybe also all the others, evidently fell after heavy winds...³²

Interestingly, investigations into the series of bomb threats against Jewish community centers took an unexpected turn when an Israeli Jew was arrested for making them. There is footage about this on the *Chicago Tribune*'s website, the subtitles of which I transcribe here:³³

"Israeli police have arrested a 19-year-old Jewish man in connection with a string of bomb threats against Jewish community centers across the U.S. There have been more than 150 bomb threats against Jewish community centers and day schools in 37 states and two Canadian provinces since Jan. 9. Israeli police spokesman Micky Rosenfeld described the suspect as a hacker but said his motives were unclear. [...] Rosenfeld said the threats were accompanied by acts of vandalism on several Jewish cemeteries."

A month later, the Israeli media reported that the young man who was arrested for making the bomb threats, identified as 18-year-old Michael Ron David Kadar, had actually made them on request.³⁴ He even advertised his "services" online at a rate of \$30 per threat. When his

case went to trial in Israel in August 2017, *NBC News* revealed that Kadar has been connected "to threats, hoaxes and extortion attempts to more than 2,000 Jewish community centers, schools, airlines, police stations and other institutions spanning more than two years."³⁵

The whole affair was therefore a scam. The question remained unanswered who gave this Israeli the orders for these 2,000 threats, and who paid the \$60,000 necessary for them. One may assume that the Jewish community centers and schools had nothing to do with it, but rather an overarching organization that had an interest in triggering hysteria. For now, we can only speculate about this.

This entire affair feeds my suspicion that someone out there thinks that, if there aren't any anti-Semitic acts in the world, they need to be invented, as they evidently serve a very important purpose...

We're contacting you regarding the following book:"

This was followed by a long list of book titles and internal Kindle ID numbers in Castle Hill Publishers' Kindle account. Then the e-mail continued as follows:

"During our review process, we found that this content is in violation of our content guidelines. As a result, we cannot offer this book for sale. If we identify additional submissions with similar content that violates our guidelines you may lose access to optional KDP services and/or face account level actions up to and including termination.





Until March 6, 2017, any of these books could be purchased from Amazon under the ID given, but ever since, when pulling up these pages, you only get to see some apologetic pooch as shown above. If you want to test it yourself without much typing, we have created a web page that has the above table with all the links set, so you can click yourself through the entire range of Amazon dogs in no time: www.codoh.com/library/document/4266.



After these 72 eBooks had been killed, next on the censor's list were the equivalent print books. When checking the U.S. and UK Amazon websites for them, the result was just as devastating. The next table shows the titles of 68 books – some of them abbreviated – which could be purchased at least from Amazon's U.S. sales page until March 6, 2017. But ever since, all you could see is once more only an apologetic pooch.

Again, on the web page given earlier, you can find the list with all links set: the titles are linked to a book-price search engine listing online bookstores where the books can still be bought, then in the next column a link to the publisher's online store, if you want to learn more about each book, and then a separate column with links to the respective page of the U.S., the UK and the German Amazon sites – now all obliterated.

It took Amazon's print-on-demand subsidiary CreateSpace, with whom we had enrolled our books for printing, five more days to inform us about this censorship. On March 11, they sent us an e-mail telling us that all the above books were indeed banned, adding four more to the initial list of 68, which are older editions that had been retired and had not been available for quite a while anyway. The e-mail states (see screenshot on the next page):

"We're contacting you regarding the following content:"

This is followed by a long list of all the above-mentioned books, alphabetically sorted. Then they state:

"During the review process, your work was found to contain material, which may include cover image, title, product descriptions or interior content, that is in violation of CreateSpace content guidelines. As a result, this content has been suppressed through your account and removed from all sales channels."


This is then followed by a threat that in case of a repeat offense they might close our account:

"If we identify additional submissions with similar content that violates our guidelines you may lose access to optional CSP services and/or face account level actions up to and including termination.


When looking at the screenshots of our account with CreateSpace after that act of book-burning, it looked like what you see on the next two pages, with most of our books being "suppressed" by Amazon.


These screenshots can also be found on the web page indicated earlier.

In addition, if you search Amazon for bestselling revisionist authors, such as Dr. Arthur Butz, professor of electrical engineering at Northwestern University (see his portrait to the right), here is what you find. His bestseller *The Hoax of the Twentieth Century*, first published in 1976, used to be available in its original as well as numerous revised and expanded later editions, new and used – see the illustration at the top of the next page showing the image results of a Google search for the book – but when you go on Amazon, it is as if the book had never even existed.



Butz's name on Amazon, this merely yielded three old issues of the long-defunct *Journal of Historical Review*, two of which weren't even available (see the illustration above). The only link between these journal issues and Dr. Butz is that he used to be on that journal's advisory board. But even these list entries were later removed, so that today only one book is cited, namely the book *Denying the Holocaust* by Deborah Lipstadt (see p. 53), who badmouths Prof. Dr. Butz in her book.



Repeat this exercise with any other revisionist publication or author that comes to mind, foremost Carlo Mattogno. None of his about 70 published titles, which are available in various languages and editions (altogether more than 300 entries) showed up at Amazon in early 2022. The only item listed is a 93-page, quadrilingual "book" (some 20 pages per language!) pretending to refute Mattogno's comprehensive work covering many thousand pages.³⁶ Already in 2014, Mattogno exposed this utter folly, which has been circulating on the Internet for years.³⁷

The results are clear: inconvenient books on Holocaust history have been wiped out, as though they had never existed – unbooks, as George Orwell might have said. Anything left over by mistake or added later, such as *The Chemistry of Auschwitz*, which was just being prepared for release at that time, was deleted as soon as the enemies of free speech found out about it.

Interestingly, among the banned books are some which don't even deal with the "Holocaust" in terms of the claimed extermination of the Jews. Here are three of them – see the cover illustrations on the



right. As usual, they can all be accessed as eBooks free of charge at www.HolocaustHandbooks.com:

- Jewish Emigration from the Third Reich. This book deals with the various measures of the Third Reich prior to the outbreak of World War Two to pressure Jews into emigrating. It does not touch upon anything that is said to have happened during the so-called Holocaust.
- The First Holocaust. This book deals with Jewish lobbying and fund-raising campaigns between the 1880s and the late 1920s using buzzwords such as holocaust, extermination and six million to garner sympathy and donations.
- The Central Construction Office of the Waffen SS Auschwitz. This book is a purely bureaucratic study of the history, structure, practices, responsibilities and activities of one department of the Auschwitz camp authorities.

These books, and their German equivalents, have in common with many of the other censored books that they are part of a series called *Holocaust Handbooks*. This is supported by the fact that all older editions of the books that form this series, often available only as used copies from third-party vendors, have been expunged as well, 69 titles in all. Here is the list as of March 2017:

Evidently, Amazon pulled the plug on the entire series without verifying whether their contents were in fact in violation of anything, because verifying the factual quality of their contents would have taken months if not years. But as Amazon writes in their <u>Content Guidelines</u>, Amazon "reserves the right to determine the appropriateness of items sold," and that's the end of that.³⁸

This pattern of book-banning clearly shows that whoever is behind it is trying to relegate the entire series *Holocaust Handbooks* to the memory hole. In addition to this, other books with dissenting views on the Holocaust that are not connected to our series *Holocaust Handbooks*, as well as books on other topics not directly related to the Holocaust, have also disappeared from Amazon. Here is a list showing those banned by mid-March 2017:

The sweeping mass ban enforced within hours clearly shows that these (68+69+18=) 155 titles were evidently censored because someone had sent Amazon a list of items to ban, and Amazon promptly complied.

And here is a Jewish newspaper gloating over this "victory" and giving us a hint as to who supplied that laundry list:³⁹

"Amazon UK has removed four books from sale which question or deny the Holocaust, following discussions with the Board of Deputies [of British Jews, that is]."

"Four books" – and one of them they quote only by its subtitle:

Butz's Hoax. It's either incompetence or mendacity.³⁹



"Amazon stopped selling three Holocaust-denial books" – but at least the JC advertised Butz's book...⁴⁰

Four books? We counted 155, and if you add the Kindle editions, that number goes up to 227! The ugly truth is that we probably missed quite a few books which were published by other publishers, so the real number might be considerably higher. *The Jewish Chronicle* even wrote about only three books.⁴⁰ Where did they get that number?

Well, admitting that they had initiated the banning of hundreds of books would probably have been bad publicity, because it smells like mass book burning. So they downplayed the whole affair.

Returning to the *Jewish News* article, I skip several lines and turn to the last paragraph on the screenshot, where we read:

Nathan Jeffay, "Under pressure, Amazon stops selling Holocaust-denial books," The Jewish Chronicle, March 8, 2017; www.thejc.com/newb&world/under-pressure-amazon-stops-selling-holocaust-denial-books-1.433963.

"After the apparent U-turn, Van der Zyl [vice president of the Board] added: 'Should any member of the public find further offending works, please get in contact with us and we will report them using the appropriate channels.'"

After their success, these traditional enemies of free speech are eager to censor more books. They evidently have established "appropriate channels" to the Amazon headquarters to get their censorship demands heard and complied with swiftly, and are asking their mostly Jewish readership to help with that.

Raising the Stakes Even Higher

In defiance of this brutal attempt at suppressing cutting-edge historical research, Castle Hill Publishers promptly republished the 13 best-selling books of these censored titles in new editions within a week using that same CreateSpace account. Yet within only a few days, on March 21, 2017 they were all taken down as well from Amazon. Here is their email on this:

"We're contacting you regarding the following content:"

This is followed by a list of 13 title IDs. In the following table, I have listed the actual titles of the books and their ISBN numbers in the order as listed by CreateSpace in their e-mail:

Then comes the same text as before:

"During the review process, your work was found to contain material, which may include cover image, title, product descriptions or interior content, that is in violation of CreateSpace content guidelines. As a result, this content has been suppressed through your account and removed from all sales channels.

If we identify additional submissions ..."

The rest of the e-mail is identical to the first one we received from CreateSpace, so I won't bore you with that. To this we responded on March 22 as follows:

"Ladies and Gentlemen:

Our books are university-style books containing archival and forensic research results by scholars who are well-respected in their field of study. It is a mystery to us how they can be in violation of any content guideline. In order to avoid any future conflict with your guidelines, please be so kind as to indicate which part of the guideline has been violated by these books.

Sincerely"

Not even an hour later, they sent us this revealing e-mail:

"As stated in our content guidelines at https://www.createspace.com/Help/Rights/ContentGuidelines.jsp, CreateSpace reserves the right to determine what content it considers appropriate. This includes both the cover art and interior content.

I'm sorry, but we can't offer any additional insight or action on this matter

Thank you for your understanding.


In other words: they wanted us to change our books, but they wouldn't commit in writing as to what exactly it is that they found offensive. Of course, we all know. But to admit it in writing could be used against them, so they kept obfuscating. Not inclined to give in, we kept pushing the envelope. This time we put only *the* bestseller up in yet another new edition from within our CreateSpace account: Dr. Nicholas Kollerstrom's *Breaking the Spell: The Holocaust – Myth & Reality* (see the cover artwork of the latest edition to the right). We simply took the same contents with no changes, put a new ISBN on it (1-59148-186-4), and put it right back into print. Retaliation was swift, because not even 24 hours after we had published that new edition, we

received this e-mail:

"Hello,

During a quality assurance review of your catalog, we found that you have repeatedly published books that have previously failed our review process. As a result, we have temporarily suspended your account.

We request that you respond to validation-request@createspace.com stating that you will improve the quality of all future submissions and that you will refrain from submitting books that have previously failed our



review process. Until we receive a response from you regarding these concerns, your account will remain blocked.

Here is our response to them on that:

"Ladies and Gentlemen:


We have never failed a review process due to a lack of quality, as our books are of such a high standard that this simply does not happen.

You are censoring our books because you bent to pressure exerted by special interest groups; not because of quality issues, but because they don't like the contents of our books, no matter what the quality is:"

That is followed by a long list of links to media articles on Amazon being pressured to ban unwelcome historical research results, some of which I have shown and cited earlier. After that, we asked Amazon basically to stop beating around the bush and to call a spade a spade.

That resulted in the following "canned" e-mail, evidently sent by a machine rather than a person:

"Hello.



Termination-of-services email from CreateSpace to Castle Hill Publishers on October 30. 2017.

We request that you respond to validation-request@createspace. com stating that you will improve the quality of all future submissions and that you will refrain from submitting books that have previously failed our review process. Until we receive a response from you regarding these concerns, your account will remain blocked.

At that point, our exchange with them was like talking to a wall, as they evidently ignored everything we were asking them. We therefore ignored them from then on as well. Since we did not comply with their impertinent request to assure them that we would, "refrain from submitting books that have previously failed our review process," they finally pulled the plug on our account on October 30, 2017 with this e-mail:

"Hello.

We contacted you regarding content guideline violations with respect to books you have submitted through your account. Since we did not receive a response from you, we are terminating your account and your Agreement effective immediately.

As part of the termination process, we will close your CreateSpace account and the related KDP account (if any) and remove the books you have uploaded through our channels from sale on Ama-

zon. Subject to the Terms and Conditions, you will receive any unpaid royalties you have earned.

Additionally, as per our Terms and Conditions, you are not permitted to open any new CreateSpace and/or KDP accounts.

If you have any questions, please e-mail us at validation-request@createspace.com"

That was the end of dissident literature on the Holocaust sold on Amazon. But it wasn't the end of Amazon censorship...

It goes without saying that we don't stop publishing books, just because Amazon decides not to carry them. And so, we've gone about our normal business since 2017, as book publishers are supposed to, and have released a number of new books and new editions of older books – such as the pictured *Air-Photo Evidence*, which as of late 2021 is in its 6th edition since 1992. All of our new books initially ended up on Amazon's web site as well by way of other publishing and distribution channels.



I include a list of books published since CreateSpace suspended our account, which have all been deleted by Amazon. I hope this list is complete and does not repeat books already found in earlier tables:

This list should also include all 44 hard-cover editions of the series *Holocaust Handbooks*, which were all unlisted by Amazon just a few days after publication in mid-2021 (ISBN 159148934-4 through 159148988-1). I refrain from including them here, as this would not add any new information.

Only a few of our books have escaped this kind of Amazon censorship, most notably the book you are holding in your hands right now, and two other books in German about censorship and persecution of dissidents (*Eine Zensur findet statt!* as well as *Diktatur Bundesrepublik Deutschland*; no published English translations exist of these booklets). Amazon obviously doesn't want to be caught censoring reports of censorship and persecution, but everything else is fair game.

On a few occasions we noticed that books which used to be banned popped up again on Amazon and were for sale for a while, only to be taken down again after a short time. So in case you encountered a book for sale on Amazon which according to our lists should have been banned, you got lucky. Whatever the reason for this was, we don't claim to understand it. Maybe some Amazon employee didn't agree with this censorship and secretly unlocked one of our books


again until Amazon received a complaint from the "never forgive, never forget" faction about it, and then promptly reversed this "mistake".

The End of Amazon


How serious Amazon was about suppressing evil anti-Semitic and Nazi material back in 2017 could be seen when searching Amazon a year after this event, meaning in early 2018, for books such as *Mein Kampf*, the Nazi bible, or for *The Protocols of the Learned Elders of Zion*, the mother of all anti-Semitic books. As you can see from the illustrations on this and the next pages, these and other "anti-Semitic" books were readily available in early 2018 in a zillion editions from various vendors. That's because these works aren't anything educated people take too seriously. As Bezos put it:

"And I'm also convinced that there's a little piece in the human brain that can immediately tell by reading somebody else's writing whether the person is smart or crazy within like the first five words."


Or maybe the powers-that-be wanted these books to be readily avail-




The Conspiracy of the Six-Pointed Star was still for sale on Amazon.com in many editions, as of February 2018.

able, because, as stated before, if anti-Semitism didn't exist, it would need to be invented. It is simply *too* useful a tool to do without. Or so I thought initially.


But think again! As soon as the censors had tasted blood, they scoured the entire Amazon offerings. If you search today (end of 2021) for the *Protocols of the Elders of Zion* or *The Conspiracy of the Six-Pointed Star*, you get almost no results, and in the case of the *Protocols*, only books that claim to expose the same as a fraud or forgery.

In the months and years following the first wave of censorship, I was contacted by self-published book authors, book sellers and owners of small publishing companies focusing on literature at the fringe of what today's Western societies accept. I could add another long list of books that fell victim to Amazon's ongoing mass murder of books now raging for almost five full years, but it cannot possibly be complete, and it would always be outdated by the time you read this. Therefore, I would like to limit this to a few honorable mentions of books whose authors or topics will give the reader an idea that this censorship cancer is indeed spreading throughout the entire body of books, affecting not just Holocaust revisionism or even merely "alternative" history, but by now much more than this.

Take the book <u>A Mighty Fortress</u> by Harold Covington, which is a novel about the creation of an ethnic state in the northwest of the USA reserved exclusively for whites after a prolonged civil war with the Union. Fiction books like this get banned from Amazon.

Another book worth mentioning is Stephen Goodson's *Inside the South African Reserve Bank*, which gives an insight into the worldwide push of leading figures in high finance to centralize banking, and thus financial power, in the hands of a selected few. That Jews had a strong influence among them is not the main thrust of the book, but it was evidently enough for the censors to ban it from Amazon.

Another book that made it on my list is Jürgen Graf's White World Awake!, which chronicles





the demographic collapse of Europe's indigenous populations and steady replacement by immigrants from Asia and Africa, while calling for a united effort of all European ethnicities to preserve their common ethnic and cultural identity. Whereas calls for ethnic and cultural self-preservation are perfectly acceptable when the intended beneficiaries are indigenous people in the Americas, in Africa, Australia and Asia, asking for the same right for Europeans gets your book banned on Amazon.



Next on my list is Nicholas Kollerstrom's *Who Did* 9/11?: A View from Across the Pond. This book is part of an entirely different genre: conspiracy theories. Whether 9/11 was the result of a few extremist Arabs conspiring or of a number of undercover government agents conspiring, it is a conspiracy theory either way, but only one of them gets your book banned by Amazon: if you disagree with the conspiratorial narrative the U.S. government has rammed down our throats.



One of Amazon's censorship decisions that should have hit the pain nerve of society – but didn't – was the banning of a set of academic books by a tenured professor: Prof. Dr. Kevin MacDonald's trilogy on Judaism, anti-Semitism, and Jewish cultural influence.⁴¹ Amazon pulled these books, first published more than twenty years earlier, from circulation in March 2019,⁴² or rather only Volumes 2 and 3, whereas the first volume, titled

When COVID-19 hit the U.S. in early 2020, so did voices criticizing the policies of masking and lockdown. One of them was Alex Berenson's trilogy *Unreported Truths about COVID-19 and Lockdowns*, which he tried to self-publish. However, Amazon initially rejected the first part of this series, claiming that it didn't meet their guidelines, without giving any specifics. ⁴⁴ Although Amazon published the books eventually (and still offers them for sale today), the damage was done, as Berenson, a former *New-York-Times* reporter, made enough noise about this attempt at censorship to get him on Fox News, where he stated in an interview with Tucker Carlson, among other things: ⁴⁵

"Berenson: They [Amazon] told me this morning, they weren't going to publish it, and then, you know, some people with loud voices said that was wrong, and they backed off. It's a good day. [...] But I think, the mistake they made is picking on somebody, or trying to censor somebody who happens to have a big enough megaphone to shout back. [...]

Carlson: If they tried to do this to you, how many others are being

censored by Amazon? Do we know?

Berenson: I think that's a great question. We don't know, because it's not like YouTube, where stuff gets posted and then pulled. They can censor on the way in, and I've heard from people already and emailed me, saying that's happening, but we don't know how many, and we don't know what the standards are."

Among those "with loud voices" was the world's richest man – the CEO of Tesla, Starlink, SpaceX, The Boring Company and Neuralink, Elon Musk, whose SpaceX is in fierce competition with Jeff Bezos's space company Blue Origin. Musk promptly tweeted on June 4, 2020:⁴⁶

"Time to break up Amazon. Monopolies are wrong!"

It took Amazon just eight months to be caught again with its fingers in the cookie jar when, in February 2021, they pulled the thoughtful 2018 book on transgender experiences titled *When Harry Became*

Sally by Dr. Ryan Anderson – a conservative but by no means radical or even extremist philosopher. You Since Amazon did not back down but has kept the book off its shelves ever since, this act of virtual book burning had a larger resonance throughout the media and society, as it was clear that four years after Amazon had introduced their censorship stance, any book ruffling the feathers of any politically "correct" group the wrong way – here evidently the LGBTQ+@&\$*§ movement and their mouthpieces – was in acute danger of being banned from the cyberstores of the world's biggest retailer. This time, Amazon's book burning shook the entire conservative spectrum of U.S. society, hence potentially almost half of its populace. The conservative TV channel Fox News, for instance, called Amazon's censorship "absurd and unacceptable." Here is an excerpt of Dr. Anderson's exchange with Fox News' news anchor Laura Ingraham:

Fox News: Censorship is bad when books they like get banned, but evil when books they hate get banned.⁴⁸

"Ingraham: At the top of the hour, the angle I mentioned, the famous novel 1984, and for many years, the Ministry of Truth was just a figment of Orwell's imagination, but today, it's real! It's just called Amazon. I say this, because Amazon has gone from simply selling books, to now banning books! Its most recent target: When Harry became Sally. [...]

Anderson: So, if you are concerned with what Big Tech can do, if you dissent from gender ideology, just wait to see what Big Government can do. Both of them are threats to our liberties and to our flourishing."

Needless to say, Fox News and all the other mainstream media outlets did not object when Amazon banned our books in early 2017, or the many other books presumably containing some, in their eyes, unacceptable right-wing ideology. Evidently, censorship is a problem to most media outlets only if it affects themselves, not so much their competitors and opponents, let alone their perceived adversaries or

enemies.

Amazon's near-monopoly market dominance, and the abuses coming with it, were the focus of a documentary of the PBS series *Frontline*, which aired on February 18, 2020. Here are some revealing passages from its transcript:⁵⁰

"Narrator: Around that time [of the introduction of Kindle, 2007], Barry Lynn, an advocate for broad anti-trust enforcement, was growing increasingly concerned by what he was hearing from publishers.

Lynn: If the door was open, the publishers would say, hey, you know, Amazon, they are just a terrific customer; they are our biggest customer; they buy the most books; they sell the most books. We love them. Then you close the door, and they say, Amazon is destroying our business model; they are destroying our business; they have way too much power. We must do something about that.

Narrator: Lynn wanted publishers to speak up publicly, and thought, federal anti-trust regulators might investigate whether Amazon was a monopoly illegally abusing its market dominance in anti-competitive ways.

Lynn: And they'd say, no way! I'm not going to talk about Amazon in public! I'm not talking about them in Capitol Hill! They will

take retribution against me.

Jacoby: *To which you responded...?*

Lynn: Well, that's why we have to do something about it!"

There is a famous quote from German theologian Martin Niemöller about the excuses people make for too easily acquiescing when someone else's civil rights are violated but not their own, which I rephrase here to make it fit the current situation with Amazon and their ilk:

First they censored the Holocaust deniers;

I remained silent, for I was no Holocaust denier.

Then they censored the Nazis;

I remained silent, for I was no Nazi.

Then they censored the nationalists;

I remained silent, for I was no nationalist.

Then they censored the conservatives;

I remained silent, for I was no conservative.

Finally they censored me,

and there was no one left to stand up for my rights.

We have reached the final stage of this game already, and there is reason for everyone to be alarmed about this development. This being so, one wonders why the usual candidates to fight for our civil rights did not speak out against such infringements, such as the American Civil Liberties Union, PEN or the American Library Association's Office for Intellectual Freedom. In fact, when we approached the Ameri-

can Library Association in 2017 to be allowed to exhibit our banned books during their annual "Banned Books Week," we were told that our books are not banned from public or school libraries, and that Amazon's decision not to carry them is simply due to a lack of "commercial interest" in our books, and our whining about it merely proves that we were sore "losers." Both claims are untrue. Our books are removed, banned, and burned from public and school libraries of every Western country on the planet – if we ever manage to get them there, that is – and Amazon was extorted into banning our books *because* they were a huge commercial success, as I demonstrated earlier.

As for the rest of the civil-rights organizations, they all insist that Amazon has the civil right to carry whatever books they please, and being denied that sales platform is no violation of anyone's civil right at all. Quite to the contrary, forcing an enterprise to sell what they do not want to sell would be a violation of their rights. There is some truth to this, but the line is drawn where a platform has grown to the point where is has a near monopoly, such as Amazon for books, You-Tube for video streaming, Google for internet searches, etc.

U.S. statutory and case law does not consider an enterprise to have a monopoly unless they have virtually total control over a market segment – such as your local utility companies have in your area, or Ingram Content Group has for book distribution. In case there is a monopoly, a company cannot arbitrarily deny doing business with a customer, but has to offer them to everyone who abides by the law.

Other countries have far lower limits of tolerance in this regard, and anti-trust laws already kick in at lower levels of market dominance. But since the U.S. is a plutocracy where Big Money rules, tougher anti-trust laws would have to be enacted by those who actually have the exact opposite interest. Hence, it won't happen. But even if there were twenty Amazons sharing equal parts of the market, what would stop the usual bullies from bullying them all into banning books the powers-that-be cannot, will not tolerate? If the vast majority of an ignorant, fanaticized, deluded society is hell-bent on suppressing a persecuted minority's peaceful views in the marketplace of ideas, what is

going to stop them?

Objectively speaking, if a company has such a dominant position in a market segment that it has the capacity to serve the entire market segment, it should not have any excuse to turn down business. To give a comparative example, I am a publisher myself, but my resources are very limited, so I cannot accept every author's manuscript that gets on my desk. I have to make choices. CreateSpace, on the other hand, has no such limitations. Other than a violation of the laws governing the territory where this company is located, there cannot be any reasonable ground why CreateSpace should be allowed to turn away any authors or publishers.⁵² The same goes for Amazon. Every momand-pop convenience store around the corner has to make choices as to what products they carry, for they have limited space and resources. That is not true for Amazon. They can and basically do stock and/or offer everything. They exclude only certain items that they dislike. And with their market dominance, this should be against the law.

Since the 1960s, US case law evolved to the point where people were no longer allowed to reject doing business with others based on their skin color, ethnic background, religious beliefs etc. But they still reject doing business with people whose peaceful views they dislike. Some views, anyway. You are not allowed to refuse doing business with a person because that person is convinced that Jews were chosen by God and are superior to non-Jews. But you can, in fact are expect-

ed to, reject doing business with a person if that person thinks that the White race was chosen by God and is superior to non-white races.

Take Ben Klassen's book <u>Nature's Eternal Religion</u> (see the cover art to the right), which tries to establish a religion exclusively for Whites to further the survival of the White Race. No matter what you think of it, the book was banned by Amazon. Any book doing something similar for

That includes quality issues, such as publishing an internet copy-and-paste hatchet job of miserable formatting quality as a "book" that would never be accepted by the average customer. If customers complain about a book's quality, this is covered by laws prohibiting false advertisement. At any rate, our customers, without exception, have been full of praise for our books' print quality and intellectual contents.

Jews is not banned. So what's the difference? Well, to put it in a nutshell, Jews were victims of the gas chambers, whereas Whites were perpetrators of the gas chambers. And that's why books challenging the gas-chamber narrative are the first kind of books getting banned and burned: to keep that pecking order intact. But it is wrong. Let the fools who think that only they and their kind were chosen by God expose their folly to the world, no matter who they are. If we start banning books because we don't like their agenda, where does the banning stop?

Following Kant's Categorical Imperative, if we turn the rules currently enforced by Amazon into a *universal* one, what world would we live in? If every book were to get banned because someone finds it offensive – and not just someone with power and clout – what books would we be left with? Only those that are so boring and meaningless that it would be pointless to read them, let alone teach anyone to learn how to read. Or to paraphrase the Swedish revisionist Ditlieb Felderer:

"If it's not banned, it's not worth reading."

As long as a book (or any other medium) espouses peaceful views, it should not be banned. However, anything that advocates, justifies, promotes or condones the violation of the civil rights of others cannot, perforce, claim to be protected by the very rights it denies others. I still do not think such utterances should be banned in every case. After all, civilized debate about restricting the civil rights of others under certain circumstances (such as violators of the law, and what the law should be) should – in fact, must be – allowed, but I think that it would be wrong to pressure or force anyone to offer such a book for sale. That's where the line must be drawn.

But back to Amazon. Unfortunately, this retail giant has not only expanded the scope and scale of its censorship since 2017 in terms of numbers and types of books banned. In fact, after the first censorship wave was over, I was puzzled as to why Amazon allowed its large subsidiaries AbeBooks and The Book Depository to continue offering the full range of Holocaust-revisionist literature by us and others. But this puzzlement was over when, sometime in late 2019/early 2020, I discovered that these platforms, too, had de-platformed all the books already banned from Amazon proper. Hence, the scourge of





this metastasizing cancer grows not only horizontally to cover more and more books and topics; it also grows vertically by encompassing more and more book outlets. Now all these platforms are intellectual deserts for dissidents.

The fact remains, however, that it all started with the kind of literature that appears to the powers-that-be as the most dangerous kind. Holocaust-revisionist books were the first to be wiped out, and that was our almost complete range of books. The historical studies among them don't deal in ideology or religion. They don't care what religious affiliations actors in history may have had. All they do is thoroughly and dispassionately analyze material traces, archival documents and witness testimony. And that's what makes them so "dangerous." Or as German journalist Patrick Bahners put it in 1994 when justifying the incarceration of peaceful historical dissidents by the German government:⁵³

"The state protects freedom of science. It recognizes the scientist not by the result, but by correct [scientific] form. [...] But it is overlooked that the intention to agitate can be recognized not only by errors of form that separate beer-hall talk from scientific undertaking. On the contrary, agitation that is perfect in [scientific] form is the most perfidious."

Between 40 and 50% of all paperback sales in the US go through Amazon.⁵⁴

Hence, we revisionists are so "dangerous" *because* we are so highly scientific. The pen is still mighty, and they sure fear *our* pens!

Amazon is the biggest book retailer of the world. According to www. statista.com,⁵⁴ their U.S. market share in consumer spending for paperback books, which is the largest sector of the market, and which is where we make some 98% of our income, was somewhere between 40 and 50% during the years 2013 to 2015, and it certainly hasn't shrunk since. Jane Friedman blogged in 2017 that some 50% of all print-book sales go through Amazon,⁵⁵ while *The Atlantic* wrote in 2014 that 65% of all online sales of *new* books go through Amazon.⁵⁶ When Ryan Anderson's book *When Harry Became Sally* was censored by Amazon in 2021, a documentary made about this case mentioned that at that time Amazon had a market share of 72% in online sales of new adult books according to the Wall Street Journal.⁵⁷

Hence, if a publisher is prevented from selling their books on Amazon, this pretty much results in the loss of some 50% to 70% of their turnover. That is exactly what we at Castle Hill Publishers experienced in the wake of most of our books having been banned from Amazon. Not many companies would survive such a catastrophic loss of business, but we manage. After all, it's not the first time we have to face such a challenge. This kind of censorship is par for the revisionist course, and if you cannot deal with it, don't get involved.







So, what can be done, you may ask? First of all, with their near-monopoly position, Amazon has become the primary threat to freedom of speech in the world. If you want to do something about it, stop buying *anything* from Amazon. Don't support the modern-day tyrants! Instead, use their website only as a merchandise search engine. Once you have found what you want to buy, google it in order to locate other vendors offering the same product. Sometimes you may even get a better deal elsewhere. But even if you don't, remember that freedom never comes free of charge. I myself haven't bought anything from Amazon since March 2017.

And don't buy from eBay either, because they ban even more dissident material than Amazon does.

And let's not wait for some miracle to happen, such as Amazon getting broken up as Musk suggested, which is unlikely to happen; but even if it did, it would probably not solve the problem, as ten smaller

wide range of online outlets where you can get them. One of the biggest book-price search engines of them all, however, <u>BooksPrice.</u> com, is in bed with Amazon and has banned all of our books as well.

So you see, the cancer is metastasizing. For instance, Barnes & Noble, Amazon's biggest competitor in the United States, silently removed all revisionist books from their repertoire the same day Amazon did.







George Orwell's *Animal Farm* has not yet been deleted, which is a good thing, because it contains a line we will all be needing to learn:⁵⁸

Castle Hill Publishers' Censorship Experiences

As mentioned earlier, Amazon's wholesale slaughter of revisionist books wasn't the first act of censorship we have encountered over the years.

We encountered the first blow in the summer of 2004, when our German bank account was confiscated by the German authorities, along with some \$5,000 of funds in it. Fortunately, in 2001 the European Union had mostly eliminated fees on electronic fund transfers between most European nations, so from then on, we simply asked our customers in Germany to pay their bills directly into our British bank account.

The next blow came with the arrest and deportation to Germany of Castle Hill Publishers' (CHP) founder and owner Germar Rudolf in November 2005, followed by a show trial and an aggregate prison term of 44 months for his publishing activities as laid out in the present book.⁵⁹ During that time, CHP was run by associates who did what they could to keep CHP alive.

During these years, first PayPal cancelled our business account with reference to a clause added a short while earlier to their terms explicitly prohibiting the sale of "Holocaust denial" material, then our British-Chinese bank HSBC closed CHP's business account. Details are unknown to me, as I was incarcerated in Germany when this happened, and because the individual dealing with it at that time, Anthony Hancock, has since passed away.

After my release from prison, it took me a while to pick up the pieces of my life and my company and to put them all back together again. Yet while doing this, the next censorship assault hit us when Jewish assemblyman Dov Hikind spread the following misleading press re-

Holocaust deniers and other groups that spout hate won't be able to sell their merchandiso through MasterCard Worldwide, according to Assemblyman Dov Hikind, who is applauding a decision by the credit card giant to stop doing business with such zany entities.

Hikind (D-Borough Park-Midwood) recently met top executives of MasterCard to thank them for their addressing what he called "this deeply hurtful issue."

Zion, The 'Gas Chambers' of Dachau, Mauthausen and Hartheim, which states that 'none of these facilities were ever used, or could have been used, as lethal 'gas chambers' and The Rudolf Report which states, 'The alleged gas chambers of Auschwitz could not have existed.'"

After not even a month, the *Brooklyn Daily Eagle*, the newspaper in Hikind's district, headlined (see the illustration):⁶¹

"MasterCard says it will cease doing business with hate groups"

By late summer of 2013, all the entities listed that I know of had lost their ability to accept credit-card payments. In a world where most financial transactions are done by credit card, this blow resulted in a catastrophic loss of some 80% to 90% of income.⁶²



Before turning to the next event, let me analyze what Hikind stated in his press release. First, a few words about Hikind's insinuation that Holocaust revisionism spreads hateful messages and is equivalent to anti-Semitism and racism. This is simply not true. While it is true that some anti-Semites and racists hold revisionist views, revisionism by definition is a scientific method, not a political or religious attitude. That some individuals are more likely to be attracted to Holocaust revisionism than others has no bearing on revisionism as a concept itself.

Next, there is no book with the title *The 'Gas Chambers' of Dachau, Mauthausen and Hartheim.* The closest to it would be *The Second Leuchter Report*, which has *Dachau, Mauthausen, Hartheim* as its subtitle (reprinted in the book shown). In it, we search in vain for the quote Hikind attributes to it. Instead we find:⁶³

"[...] the alleged gas chambers at the above inspected sites could not have then been, or now be, utilized or seriously considered to function as execution gas chambers."



Although Hikind caught the gist of it, still, if it's not a verbatim quote, don't put quotation marks around it.

His second quote is similarly shoddy, which gives the impression of originating from my expert report – see the cover artwork of the first English edition of 2003 in the illustration to the right. It does not state anywhere that "The alleged gas chambers of Auschwitz could not have existed." Instead, my two main conclusions read as follows:⁶⁴

"On physical-chemical grounds, the mass gassings with hydrogen cyanide (Zyklon B) in the supposed 'gas chambers' of Auschwitz claimed by witnesses did not take place. [...]

The procedures of mass-gassing as attested to by witnesses during their interrogation before various courts of law, as cited in judicial rulings, and as described in scientific and literary publications, in any building of Auschwitz whatever, are inconsistent with documentary evidence,



technical necessities, and natural scientific law."

Again, the gist is there, but an accurate quotation would have suggested to the reader that revisionist arguments are much more complex than what Hikind evidently wanted his readers to understand.

But there is a much wider issue in play here, which we must not lose sight of: Dov Hikind's global outreach to ruin businesses whose agendas he detests is utterly un-American. Jett Rucker explained it aptly in a 2013 article, from which I quote:⁶⁵

"Why is such a global enterprise, in behalf of a majority, one supposes, of the 66,000 or so voters in his District 48 of New York, Unamerican? Well, we could start with 'freedom of speech,' another concept, along with 'Unamerican,' that has become quite fusty from disuse. The Constitutional bar against Congress enacting any measure that abridges freedom of speech, much honored by now in the breach, does not bear on Assemblyman Dov Hikind, nor even, necessarily, on the State of New York, and certainly not on American Express, Mastercard, and the various other arbiters of the international payment system that so many of us rely upon to conduct our transactions — and, it would seem, to form our opinions.

Hikind's projects, then, are not unconstitutional. So, why are they Unamerican? The bar on Congress, it might be speculated, arose

from the Founding Fathers' awareness that the power to prohibit expression would be ineluctably captured by those intent on enforcing beliefs that those currently in power were the most-fit to exercise it, and that such power should be exercised only by sanctioned parties.

The Founding Fathers hoped to prevent such hijacking of the public faith. Unfortunately, they did not figure on credit cards and the regulation of banking that has reduced management of this critical facility to a government-dependent monopoly. The credit-card companies, a cartel protected and managed by the government, have become a lever handy to the grasp even of tin-horn despots such as Dov Hikind for the advancement of parochial agendas. One supposes that Hikind's constituency, whether that of the 66,000 voters of Borough Park or that of Holocaust censors worldwide, are gratified by his noxious success.

But, a romantic might posit, there might be something further in the Americanness of the ideal of free speech. That is the simple idea of Fair Play for those who express honest opinion informed, however incompletely, by fact. There might be, in this penchant for Free Speech that some Americans have obdurately held onto for these two centuries and more, a respect for the honest opinion, or speculation, of one's fellow man. To stand against this, and to work against it, is what is Unamerican about Dov Hikind's reprehensible effort to throttle free expression that so threatens, in the end, the foundation of his own political base.

We (Americans, citizens of the world) can mobilize force, legal, financial, and otherwise, against the expression of ideas, thoughts, feelings, however motivated. Or, we can allow each other to be free with such activities, and hash the issues out in open discourse, unencumbered, insofar as this is socially possible, by suppression, censorship, and all other barriers to the free exchange of opinion.

This freedom is exactly what the Dov Hikinds in the world stand against."

After regrouping, we launched an effort in late 2013 to get a strong foothold on Amazon.com by placing our products using their e-commerce platform "Marketplace." That project, however, was nixed around Christmas 2014, when Amazon shut down our account due

to an alleged lack of customer-service quality, even though we had not a single complaint by any customer and only rave reviews by highly satisfied patrons. In fact, the real reason to kick us out was that one of the books published by a U.S. company, which we had licensed for sale in the UK, turned into a bestseller overnight – see the cover artwork shown here. 66 Proof for this is the fact that the U.S. publishers of that book had their Amazon Marketplace account shut down at the very same time for the very same threadbare, even mendacious reason.



At that time, we were already getting our feet wet with Amazon's print-on-demand subsidiary CreateSpace. After Amazon had thrown us out of their "Marketplace," we switched over to CreateSpace, hoping that this one would last for a while. As you can see from the story told in the present book, it lasted a little over two years before that one went bust, too.

And what was next? Well, on January 18, 2018, we received the following e-mail from our credit-card processing company:

"The following updates have been made to your merchant account:

- Amex account removed

Please contact us at the phone number provided on your statement if you have questions regarding this update."

When we inquired why American Express had been removed from our account, they told us they had no information why AmEx had pulled the plug. When we contacted AmEx, they stated that AmEx, after a "proprietary review" of their relationship with us, had decided to sever that relationship. Since we did not have a direct relationship with them but rather through an agent, the customer representative

stated that he is unable and unauthorized to divulge any information about the reasons for this severance.

And guess who is at it again, inspired by the fake bomb threats and non-vandalized Jewish cemeteries discussed earlier:⁶⁷

Assuming he's doing with taxpayer money what he likes best, it is not far-fetched to assume that he and/or those of his ilk were behind it when we lost our contract with our credit-card-service provider altogether at the end of June 2019, because our gateway provider, Authorize.net, had abandoned us without making so much as a peep about it.

Moreover, a few weeks before that, on June 10, 2019, YouTube blocked all our video channels, after this Google subsidiary had already announced in early June 2019 that it would delete videos with Holocaust-revisionist content. Since YouTube has a virtual monopoly in video streaming, this cut off our access to hundreds of thousands, even millions of people, because that is how successful some of our videos were. Most of our self-produced documentaries can be viewed on the website www.HolocaustHandbooks.com, but John Doe can only find them there if he already knows what to look for. Although by now we have a very successful video channel on BitChute, he had to stop our paid video production, because we simply could not reach the masses anymore, and the production costs could no longer be covered.

Just a few days after we had managed to reinstate credit-card payments on our site, we learned about the following article by the Israeli news website YNetNews.com, published on July 12, 2019:⁷⁰

"After a years-long legal battle by the International Association of Jewish Lawyers and Jurists (IAJLJ), the German government last week ordered Holocaust revisionist publisher Castle Hill Publishers to shut down its online store.

The British-based anti-Semitic publishing house founded by convicted Holocaust denier Germar Rudolf specializes in the distribution of books and periodicals in English and German that deny the Holocaust.

As of late, the website has not been available in Germany but is still accessible in other countries, including Israel. The legal precedence in Germany, where Holocaust denial is a criminal offense, is that the website is not German in origin.

Other than Holocaust denial literature, Castle Hill Publishers also

hires 'researchers' who probe for material and evidence to back up their claims about the Holocaust.

Among titles up for sale on the website can be found books such as 'Treblinka – Extermination Camp or Transit Camp?', 'Breaking the Spell – The Holocaust, Myth & Reality' and 'The Hoax of the Twentieth Century – The Case Against the Presumed Extermination of European Jewry.'"

When I read that, I had to laugh: the German government ordered us to shut down our online store? That never happened, and we sure don't take orders from totalitarian dictatorships to forfeit our civil right to freedom of speech! It is true, however, that the German government threatens to prosecute the CEO of every internet-service provider in Germany whose company makes our website's contents accessible to German visitors. As a result, many Germans unfamiliar with anonymizing virtual-private-network technology (VPN) can no longer access our website.

YNet also deplores that, in addition to selling our literature, we have the audacity to hire researchers who probe for material and evidence to back up our claims about the Holocaust. How evil of us, indeed. However, last time I checked, Israel does the same thing through their evidence-denying establishment called Yad Vashem and many other venues, and many universities around the globe today pride themselves on having some type of Holocaust research center, or at least an academic chair staffed with "researchers" who get paid to back up the flawed orthodox narrative with "evidence." That is par for the course, and if paying people to back up claims were a legitimate reason to shut down websites, there would be few websites left standing.

The next wave of trouble for us came at the end of 2020 in the wake of "Brexit," the UK's exit from the European Union. Since we have been conducting our book distribution in Europe from England since 1996, Brexit meant for us that the dictatorships of mainland Europe, first and foremost Germany and Austria, would now carry out customs controls on mailings from England. And guess what happens when they discover what books we are importing... Confiscations have therefore happened more frequently since then, and our customers have sometimes been harassed by Germany's State-Protection Squads, modern Germany's equivalent of the Gestapo of yore. As a

result, we withdrew from England – along with thousands of other companies for whom the new customs and duty regulations made financial survival impossible.

A year and a half after the YouTube mass murder of our documentaries and two weeks after Brexit, it was once again the credit-card-service providers who were causing us headaches. On January 14, 2021, our credit-card-service provider, National Processing, decided we were "evil" after one of its gateway providers, Paysafe.com, let us down that same day, writing in an email:

"Good afternoon,

I am reaching out to inform you that this account has been closed. It was brought to our attention of what is being sold on your website. These products are classified as hate speech. No funds have been held."

Looking at the pattern of censorship we have experienced over the years, it emerges that the beginning of each year seems to be the most challenging for us. The reason for that seems obvious. In 2005, the General Assembly of the United Nations officially declared the 27th of each January "an annual International Day of Commemoration in memory of the victims of the Holocaust." January 27, 1945 was the day when the Red Army entered the Auschwitz Camp. I intentionally refuse to use the word "liberated" in this context, because the Red Army did never liberate anyone; they merely conquered, and subjugated those "liberated" to totalitarian Stalinist rule.

Ever since that year in particular, certain partisan groups have driven censorship campaigns against skeptical Holocaust researchers and their published research result mainly during that time of the year.

The same happened again in early 2022, when Germany and Israel ganged up to make the General Assembly of the United Nations pass another resolution appealing to all nations of the world "to reject without any reservation" and "to take active measures to combat" any unwanted skeptical research into the National-Socialists' persecution of the Jews, and the popular social-media chatter resulting from it. This resolution passed without a vote on January 20, 2022.⁷²



The enormity of what happened on that day at the General Assembly of the United Nations needs to be understood: This resolution is in clear violation of the United Nation's Declaration of Human Rights, which guarantees freedom of speech in both its Preamble and in Article 19.73 On that day, *all* governments of the world agreed to do everything possible to curtail that freedom *on the entire planet*! (Well, Iran spoke out against that resolution, but not because they were worried about free speech...). In other words, when it comes to freedom of historical research, the General Assembly of the United Nations is an assembly of dictatorships and tyrannies, with shades in color, but not in principle.

When we heard about this resolution, we braced for impact. Something sure was coming our way again...

On January 24, the company we used at that time to have our books printed, distributed and mailed to our customers, Lightning Source, which is a subsidiary of the almighty Ingram Content Group, sus-

pended all our books. We could not even place any orders for our own customers. A day later, all books were available again for us to place individual orders for our own customers, but all books had been removed from distribution through Ingram, which basically has a monopoly on book distribution in the U.S. In fact, in a video meant to promote Ingram, they brag about the fact that they are "behind every book,"⁷⁴ because pretty much every new book that gets printed in the U.S. goes through Ingram as the intermediary between publishers on the one hand and book retailers on the other.

When we asked Ingram what the reason was for this censorship action was, we received the following email on January 26:

"Dear Publisher,

Please be advised that due to recent complaints of your titles from retailers we are providing notice to terminate your account effective March 7, 2022, as outlined in our agreement under section 6b (page 12).

During this time your titles will only be available for short-run ordering.

Sincerely,

Catalog Integrity Team"

That Section 6b reads succinctly:

"b) Termination for Convenience. Publisher may terminate this Agreement without cause by giving the other Party forty-five (45) days written notice. Lightning Source may terminate this agreement with or without cause, immediately upon written notice to Publisher."

To this I merely responded, without having heard back from them:

"This is peculiar. No retailer is forced to sell or even offer our books, if they don't like them, so why would they complain?

Is there any way of letting us know what the contents of those complaints were?"

Brick-and-mortar book shops most certainly have no influence on which books Ingram offers as a distributor. If they don't like a book, they simply don't carry it. It is different with the big book chains and online book retailers. In the U.S., they get their book data with which they fill their websites directly from Ingram via a live ftp hook-up. Ingram feeds all these sites, without exception, every day with updates of new books released, revisions made, and books withdrawn. That's why you could always find our books on Amazon for at least some time after we had released a new book or a new edition. Amazon and all the rest of the websites in the U.S. where you get your books have all their data fed in real time and automatically by Ingram. If they want to ban any book Ingram carries, they have to go into this data of millions of book and manually delete the ones they despise. It is a real hassle for them to do that, as it requires perpetual monitoring and, if something offensive is spotted, manual intervention into their

database contents.

So, guess which retailer with lots of clout and influence has had enough of our, at times, successful undermining of their censorship efforts and put the thumbscrews on Ingram, using the UN Resolution just passed as a broad hint? With Amazon having a 72% market share in new online book sales, a similar percentage of Ingram's sales also probably goes to Amazon. Hence, if Amazon is unhappy, Ingram better clean up...

When Ingram, probably bullied by Amazon, pulled the plug on us, our books disappeared *from the entire worldwide book market*, except for our own web shop as well as a few smaller retail outlets specializing in niche products such as we publish.

Not quite a month after this blow, we received a love letter from our British bank, Barclays, with whom we had been doing business for the past 15 years without ever encountering any problems, no matter the pressure domestic or foreign individuals or entities exerted on them. But then, someone must have used the recent UN resolution to make them change their minds (see the reproduction of their letter overleaf):

"Dear Sir

We are closing your account(s)

We're sorry, after careful consideration, we've taken the decision to close your account(s) and all facilities on 24.04.2022."

No further reason was given except for a reference to their retail-customer agreement which simply states that Barclays can close any account with two months' notice for no reason at all.

Now we're in the next round of the battle for free speech, which is to be reported in the next edition of this book...

As Elon Musk was aptly paraphrased in early 2021 when he was ticked off by the censorship wave on social media in response to the riot on Capitol Hill in January 2021:

"They don't ban hate speech, they ban speech they hate!"

The more enemies, the merrier!

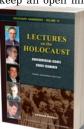

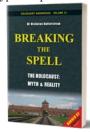
Breaking the Spell. The Holocaust, Myth & Reality. By Nicholas Kollerstrom. In 1941, British Intelligence analysts cracked the German "Enigma" code. Hence, in 1942 and 1943, encrypted radio communications between German concentration camps and the Berlin head-quarters were decrypted. The intercepted data

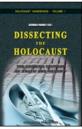

Debating the Holocaust. A New Look at Both Sides. By Thomas Dalton. Mainstream historians insist that there cannot be, may not be, any debate about the Holocaust. But ignoring it does not make this controversy go away. Traditional scholars admit that there was neither a budget, a plan, nor an order for the Holocaust; that the key camps have all but vanished, and so have any human remains; that material and unequivocal documentary evidence is absent;

This in turn unleashed a tsunami of persecution against him: lost his job, denied his PhD exam, destruction of his family, driven into exile, slandered by the mass media, literally hunted, caught, put on a show trial where filing motions to introduce evidence is illegal under the threat of further prosecution, and finally locked up in prison for years for nothing else than his peaceful yet controversial scholarly writings. The laws of Judaism hold Gentiles in very low regard; they can be cheated, lied to, abused, even killed, if it serves Jewish interests. 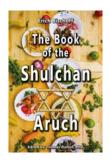

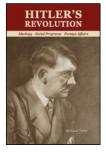

However, Hitler's take on the Jews is far more complex and sophisticated. 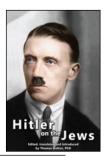
Goebbels on the Jews. By Thomas Dalton. From the age of 26 until his death in 1945, Joseph Goebbels kept a near-daily diary. It gives us a detailed look at the attitudes of one of the highest-ranking men in Nazi Germany. Goebbels shared Hitler's dislike of the Jews, and likewise wanted them removed from the Reich. Ultimately, Goebbels and others sought to remove the Jews completely from Europe—perhaps to the island of Madagascar. This would be the "final solution" to the Jewish Question. Nowhere in the











diary does Goebbels discuss any Hitler order to kill the Jews, nor is there any reference to extermination camps, gas chambers, or any methods of systematic mass-murder. Goebbels acknowledges that Jews did indeed die by the thousands; but the range and scope of killings evidently fall far short of the claimed figure of 6 million. This book contains, for the first time, every significant diary entry relating to the Jews or Jewish policy. The Jewish Hand in the World Wars. By Thomas Dalton. For many centuries, Jews have had a negative reputation in many countries. Streicher, Rosenberg, and the Jews: The Nuremberg Transcripts. Thomas Dalton, Who, apart from Hitler, contrived the Nazi view on the Jews? And what were these master ideologues thinking? During the postwar International Military Tribunal at Nuremberg, the most-interesting men on trial regarding this question were two with a special connection to the "Jewish Question": Alfred Rosenberg and Julius Streicher. The cases against them, and their personal testimonies, examined for the first time nearly all major aspects of the Holocaust story: the "extermination" thesis, the gas chambers, the gas vans, the shootings in the East, and the "6 million."
